#### Qualifying criteria for Small Business Rates Relief discounts from 1st April 2017

- The property must be occupied
- The rateable value of the property must be less than £15,000.
- The ratepayer must only have **one occupied property** in England, except we will disregard your occupation of an additional property in England where:
  - its rateable value shown in the local non-domestic rating list for that day is not more than £2,899; and
  - the aggregate rateable value on that day of all the properties the ratepayer occupies in England is not more than £27,999.
  - The ratepayer is not a charity or a sports club registered with the Community Amateur Sports Club scheme (CASC).

#### The amount of relief that you will receive is dependent on your rateable value

- If your rateable value is £12,000 or less then you will receive 100% relief, meaning you will not have to pay any business rates
- If your rateable value is between £12,001 and £15,000, the discount you are eligible for is calculated on a sliding scale. A Rateable Value of £15,000 receives no discount and £12,000 receives 100% discount. To calculate the discount percentage you will receive, subtract your rateable value from £15,000 and divide that figure by 30.
- There is no need to apply for small business rates relief if your rateable value is between £15,000 and £50,999 as the small business rate multiplier will be granted to you automatically even if you have multiple properties.

#### Notifying us about changes

- Once small business rates relief is granted there is no need for you to reapply
- You must notify us immediately when:
  - You occupy another property that you did not occupy at the time of your relief application or
  - There is an increase in the rateable value of a property you occupy outside Hammersmith and Fulham Council's area

It is a criminal offence for a ratepayer to give false information when making an application for small business rate relief
